Thank you for writing about the external hard drive you purchased on January 11, 2015. I know from personal experience how frustrating it is when a drive fails.

According to your letter, you used the drive to store the business plan for your new consulting business. When you attempted to copy that file to your external drive, the external drive failed, and the business plan was lost. You have no other copy of that file. You are asking us to reimburse you \$1200 for the cost of creating that business plan from scratch and reformatting the drive.

As you know, our drives carry a lifetime guarantee covering parts and workmanship. We will gladly replace the defective external drive. However, the guarantee covers the drive, manufacturer and the retailer, not the value of the external drive, not for the cost of duplicating the work that went into making the file stored on the drive.

However, your file might still be recoverable. A reputable data recovery firm might be able to retrieve data from the drive at a very reasonable cost. To prevent such problems in the future, we always recommend that you back up all valuable files periodically.

Bringing to mind the customer on which goodwill is based allows addressing the customer in light of what you say "We are sorry that the drive you purchased from us did not work. We will honor the customer's claim if the dispute ends in their favor."

The writer emphasizes the fact that the incident, as he sees them.

The writer explains that he is unable to fulfill the reader's request. He states that the writer must explicitly direct the request to another officer to explain why granting the request is not appropriate. Also note that the writer does not explicitly say that he would like to make a backup copy of the plan and transfer the problem to her.

The writer shifts from the bad news to the good news. The writer explains that he has already responded appropriately to the reader's request.
